

- Created by a group of concerned citizens in the Town of Caledon
- ROAD WATCH program targets dangerous, aggressive driving through AWARENESS, EDUCATION & ENFORCEMENT



- Policing resources are being maxed to the limit
- Our town is continuing to increase in population
- The motoring population continues to increase both within the Town and commuter traffic



- ROAD WATCH is a community based initiative, that allows the public to get involved in their own community
- We achieve this objective by taking a three prong approach AWARENESS, EDUCATION AND ENFORCEMENT

 AWARENESS: Is accomplished by putting on presentations, seminars, media coverage, advertising, printed promotional material all made available to the community EDUCATION: is promoted at several levels from elementary to high school. Currently participated in the high schools "Sweet Life Challenge" an initiative created by the Ministry of Transportation and partnered with ROAD WATCH
