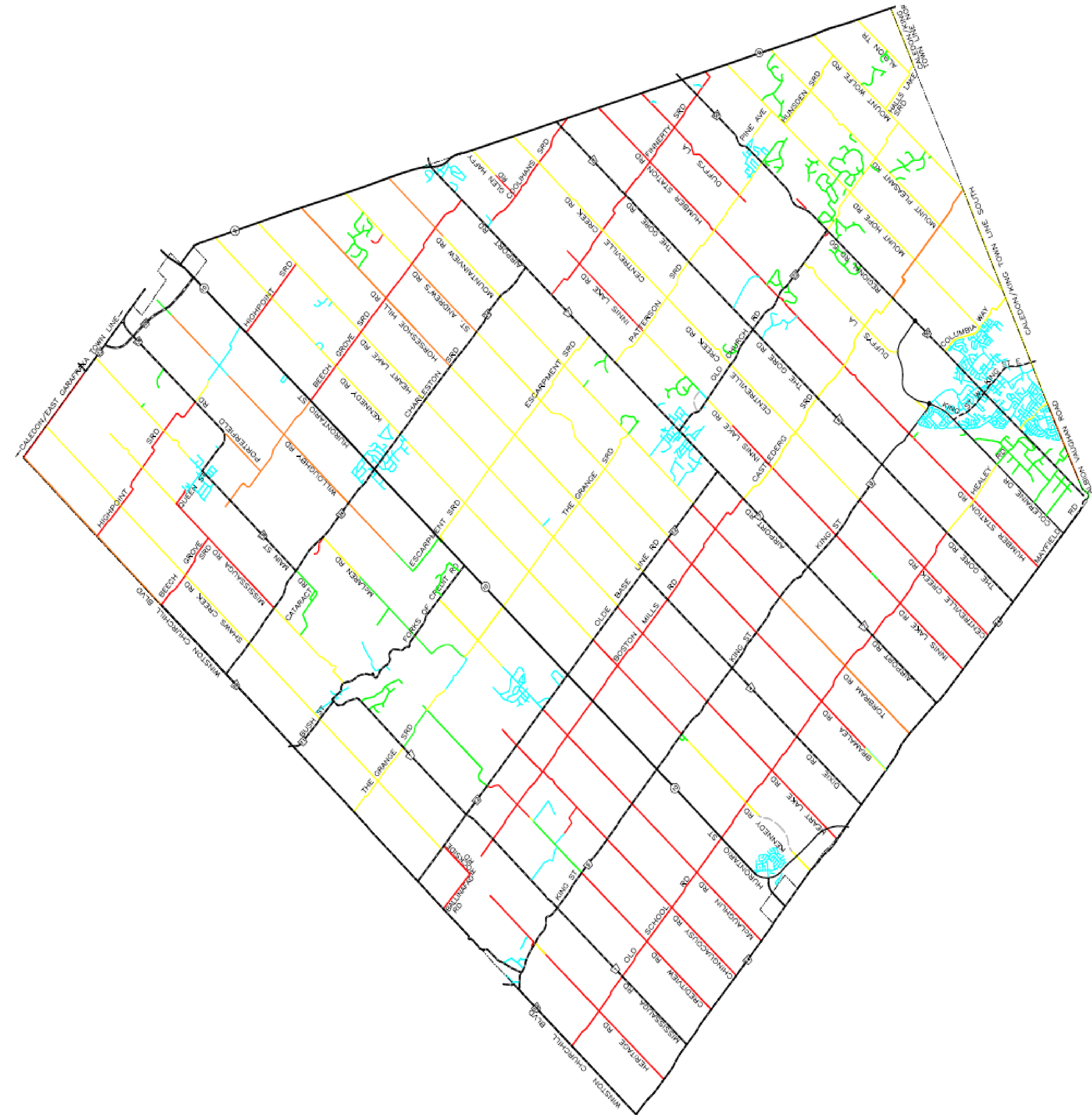

- + Town of Caledon historically has implemented:
 - + 80 km/h speed limits in rural areas
 - + 40 km/h speed limits in urban areas
- + Recently, some newer areas of development have adopted 50 km/h
 - + Consistent with the HTA 'default'
- + Changes in speed limits over time created inconsistencies throughout the Town:
 - + Similar roads with different speed limits
 - + Dissimilar roads with same speed limits



- + A full road network speed limit review was undertaken, based on guidelines from the Transportation Association of Canada (TAC), to:
 - + Provide consistency within the town's new developments and older urban roadways
 - + Provide realistic and uniform speed limits
- + Credible speed limits can enhance safety
 - + Driver perception of road environment vs. posted speed limit
 - + Minimize speed differential
 - + Increase compliance



Urban/Semi-Urban Environments



Rural Environments



Default Speed
Limit

- 50 km/h, consistent with Highway Traffic Act

Rural Network
(‘Grid’)

- TAC Recommended Speed Limit as a base + engineering judgement
- Observe corridor and network consistency

- Villages and hamlets to remain 40 km/h
